AN ORDINANCE AUTHORIZING SALARIES TO BE PAID TO THE EMPLOYEES OF THE BOROUGH OF AUDUBON PARK, COUNTY OF CAMDEN, STATE OF NEW JERSEY, DESIGNATING THE VARIOUS POSITIONS, AMOUNTS OF SALARY AND TIME OF PAYMENT

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Audubon Park, County of Camden and State of New Jersey, Section 1. of the aforesaid Ordinance is hereby amended to read as follows:
