**ORDINANCE OF THE BOROUGH OF AUDUBON PARK, COUNTY OF CAMDEN
AND STATE OF NEW JERSEY AMENDING ORDINANCE NO. 2015-03, ENTITLED
“DOGS, GENERAL REGULATIONS”**

WHEREAS, the Borough of Audubon Park (“Borough”) is a municipal entity organized and existing under the laws of the State of New Jersey and located in Camden County; and

WHEREAS, on April 6, 2015, the Governing Body adopted Ordinance No. 2015-03 which repealed and replaced Ordinance No. 2010-09 establishing licensing requirements and regulating the ownership and control of dogs within the Borough; and

WHEREAS, Section 1.4 of Ordinance No. 2015-03 established certain licensing fees regarding the registration of dogs; and

WHEREAS, the aforementioned Ordinance has been determined by the Mayor and the Borough Council (the "Governing Body") to be in need of revision and modification with respect to said fees; and

WHEREAS, pursuant to N.J.S.A. 40:48-2, the Governing Body is authorized to enact and amend ordinances as deemed necessary for the preservation of the public health, safety and welfare and as may be necessary to carry into effect the powers and duties conferred and imposed upon the Borough by law;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Audubon Park, County of Camden, and State of New Jersey, as follows:

SECTION 1: Ordinance No. 2015-03, entitled “Dogs, General Regulations”, Article I, entitled “Dogs; Licensing and Registration”, Section 1.4, entitled “License and tag fees; Late fees” is hereby amended, revised and/or supplemented to read as follows:

1.4 License and tag fees; Late fees

SECTION 3: All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

SECTION 4: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 5: This Ordinance shall take effect upon passage and publication according to law.
