**AN ORDINANCE AUTHORIZING

DESIGNATING THE VARIOUS POSITIONS, AMOUNTS OF SALARY AND TIME OF

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Audubon Park, County of Camden and State of New Jersey, Section 1. of the aforesaid Ordinance is hereby amended to read as follows:
